## **Unique Student Identifier (USI)**

#### What is a USI?

A Unique Student Identifier (USI) is a 10 character reference number made up of numbers and letters. A USI allows an individual to see all of their training results from all providers for all accredited training units and qualifications completed.

You must provide your USI when undertaking any form of accredited training.

Australian Training Plus delivers workplace-based traineeships and apprenticeships across a wide range of qualifications.

Traineeships and Apprenticeships can form an integral part of your business recruitment and training strategy and supports an individual to achieve their learning and career pathway goals.

#### Employing trainees and apprentices enables you to:

- Bring new skills into the business to increase your competitiveness
- Prevent future skills shortages and safeguard your business
- Access Government funding, incentives and rebates if eligible
- Train staff to suit the unique needs of your business

#### **Opportunities for Funding**

Under the NSW Fee Free Apprenticeship & Traineeship Initiative, trainees and apprentices may be eligible for fee free training (must meet eligibility criteria) under NSW Smart and Skilled funding.

#### In addition to subsidised training, employers may also be eligible for other incentives:

- Wages of apprentices and trainees may be less than those of skilled workers
- Standard incentives of up to \$4000.00\*
- Workers Compensation exemption\*
- Payroll tax off-sets\*
- Extra incentives may be available to assist in the employment of those with a disability, mature-aged, school-based and indigenous Australians.

Trainees and Apprentices may also be eligible for additional incentives to support the completion of their qualification. \*Eligibility criteria applies and in some cases is State specific. Benefits and services are subject to change at any time without notice.

#### **Boosting Apprenticeship Commencements**

Boosting Apprenticeship and Traineeship Commencements are supporting businesses to take on new apprentices and trainees. Employers who engage an Australian apprentice or trainee may be eligible for a subsidy of 50% of gross wages paid - to a maximum of \$7,000 per quarter for a 12 month period.

#### **Trainee and Apprentice Fee Free Initiatives**

• Under the NSW Government Fee Free Apprenticeship Initiative, NSW apprentices that commence their training on or after 1 July 2018 may be eligible for fee free training. For more information go to vet.nsw.gov.au. For eligible apprentices there will be no requirement to pay the fee.

• Under the NSW Government Fee Free Traineeship Initiative, NSW trainees that commence their training on or after 1 January 2020 may be eligible for fee free training. For more information go to vet.nsw.gov.au. For eligible trainees there will be no requirement to pay the fee.

**Existing Worker Traineeships** are also available as a Fee for Service training opportunity and prices can be provided upon application, per student and qualification.

## **Traineeships and Apprenticeships**

The 2021 federal budget included a suite of measures designed to address workplace shortages, boost skills levels and get more people back in work. The Boosting Apprenticeship Commencements wage subsidies have been extended, which reimburse employers for the wages of new apprentices and trainees by up to 50%.

Hiring an apprentice or a trainee can be a great option to grow your business as well as employment opportunities for the community. Australian Training Plus is well equipped to assist business owners navigate the incentives and the paperwork that goes with it.

Traineeships and apprenticeships are often a pathway for younger people into work, however they can also be an option for more mature and experienced people looking for a change in career and an opportunity to expand their horizons. ## Safe Food Handling

#### \$110.00 per person RTO ID 91434

#### **Overview**

This course describes the performance outcomes, skills and knowledge required to use personal hygiene practices to prevent contamination of food that might cause food-borne illnesses. It requires the ability to follow predetermined organisational procedures and to identify and control food hazards.

The course applies to all organisations with permanent or temporary kitchen premises or smaller food preparation or bar areas. This includes restaurants, cafes, clubs, hotels, and bars; tour operators; attractions; function, event, exhibition and conference catering; educational institutions; aged care facilities; correctional centres; hospitals; defence forces; cafeterias, kiosks, canteens and fast food outlets; residential catering; in-flight and other transport catering.

It applies to food handlers who directly handle food or food contact surfaces such as cutlery, plates and bowls during the course of their daily work activities. This includes cooks, chefs, caterers, kitchen stewards, kitchen hands, bar, and food and beverage attendants, and sometimes room attendants and front office staff.

Course covers unit of competency: SITXFSA001 - Use hygienic practices for food safety.

#### **Entry requirements or Pre-requisites**

There are no entry requirements or pre-requisites for this course.

Please note, this unit of competency is a prerequisite for Food Safety Supervisor training if you wish to obtain a NSW Food Authority Food Safety Supervisor Certificate.

## **Coffee Skills**

#### \$285.00 per person

**RTO ID 91434** 

#### **Overview**

This course aims to equip learners with the skills and knowledge required to extract and serve espresso coffee beverages using commercial espresso machines and grinders. It requires the ability to advise customers on coffee beverages, select and grind coffee beans, prepare and assess espresso coffee beverages and to use, maintain and clean espresso machines and grinders.

This course applies to any hospitality organisation that serves espresso coffee beverages, including cafes, restaurants, bars, clubs, function and event venues. It applies to espresso machine operators who operate with some level of independence and under limited supervision.

Course covers unit of competency: SITHFAB005 - Prepare and serve espresso coffee.

#### **Entry requirements or Pre-requisites**

SITXFSA001 - Use hygienic practices for food safety is a pre-requisite unit for this course. Learners must hold this unit or attend a Safe Food Handling course prior to commencing this course.

## Cocktails

#### \$230.00 per person

**RTO ID 91434** 

#### **Overview**

This course describes the performance outcomes, skills and knowledge required to prepare and serve a range of cocktails. It requires the ability to promote, prepare and present attractive cocktails and experiment with ideas to develop new cocktail recipes.

The unit applies to any hospitality organisation that operates a bar that serves cocktails, including hotels, restaurants and clubs.

The preparation of cocktails is a high order technical bar attendant skill used by experienced beverage attendants who operate independently or with limited guidance from others.

The sale and service of alcohol is subject to the provisions of Responsible Service of Alcohol (RSA) law in each state and territory of Australia. Skills and knowledge for compliance with this law are covered by the prerequisite unit SITHFAB002 Provide responsible service of alcohol.

Course covers unit of competency: SITHFAB010 - Prepare and serve cocktails

#### **Entry requirements or Pre-requisites**

SITHFAB002 Provide responsible service of alcohol SITXFSA001 Use hygienic practices for food safety

## **Wine Appreciation**

#### \$185 per person

**RTO ID 91434** 

#### **Overview**

This course describes the performance outcomes, skills and knowledge required to evaluate a range of Australian wines; provide advice to customers on their selection; and continuously extend personal product knowledge.

The unit applies to hospitality, winery, retail and wholesale organisations that sell Australian wines. It applies to personnel who operate independently or with limited guidance from others and who have substantial specialist knowledge of Australian wines. This includes beverage sales consultants, winery sales staff, bar specialists, sommeliers, and senior bar and food and beverage attendants.

The sale and service of alcohol is subject to the provisions of Responsible Service of Alcohol (RSA) law in each state and territory of Australia. Skills and knowledge for compliance with this law are covered by the prerequisite unit SITHFAB002 Provide responsible service of alcohol.

Course covers unit of competency: SITHFAB012 - Provide advice on Australian wines

### **Responsible Service of Alcohol (RSA)**

#### \$185.00 per person

**RTO ID 91434** 

#### **Overview**

Responsible practices must be undertaken wherever alcohol is sold or served, including where alcohol samples are served during on-site product tastings. This unit, therefore, applies to any workplace where alcohol is sold or served, including all types of hospitality venues, packaged liquor outlets and wineries, breweries and distilleries.

The course applies to all levels of sales personnel involved in the sale, service and promotional service of alcohol in licenced premises. Those selling or serving alcohol may include food and beverage attendants; packaged liquor sales persons selling in person, over the phone or online; winery, brewery and distillery cellar door staff; and supplier sales representatives.

The course also applies to security staff who monitor customer behaviour and to the licencee who is ultimately responsible for responsible service of alcohol (RSA) management. The course meets knowledge requirements under NSW liquor licensing law for employees engaged in the sale or service of alcohol.

Australian Training Plus is approved by Liquor and Gaming NSW to deliver RSA classroom based training and assessment for the issue of a NSW RSA Competency Card.

Course covers unit of competency: SITHFAB002 – Provide responsible service of alcohol.

#### **Entry requirements or Pre-requisites**

There are no pre-requisites or entry requirements for this unit. Please note, undertaking this qualification prior to turning 18 years of age is permissible however individuals cannot serve or sell alcohol until they have turned 18.

The RSA Competency Card is currently valid for a period of 5 years.

## **Responsible Conduct of Gambling (RCG)**

#### \$145.00 per person

**RTO ID 91434** 

#### **Overview**

Responsible gambling services must be provided wherever gambling activities are undertaken. In the hospitality industry, the gambling environment is usually referred to as the gaming area and is provided in a range of venues, such as hotels, motels, clubs, pubs and casinos. The major forms of gambling are wagering (racing and sport) and gaming (gaming machines, table games, Keno and lotteries). Both forms of gambling are relevant to the hospitality industry.

Responsible provision of gambling services is an essential underpinning skill for all hospitality personnel involved in the sale and service of gambling activities in licenced premises, including the licencee, gaming supervisors and gaming managers when involved in operational gambling activities.

The course applies equally to frontline operational gambling personnel who operate with a limited level of autonomy and under some supervision and guidance from others. They would operate within predefined organisational procedures, and regulatory authority and industry and organisational codes of conduct.

Operational job roles would include gaming attendant, table game attendant, croupier and multi-skilled food and beverage attendant.

The course satisfies the requirements for providing responsible gambling services under NSW legislation. Australian Training Plus is approved by Liquor and Gaming NSW to deliver RCG classroom based training and assessment for the issue of a NSW RCG Competency Card.

Course covers unit of competency: SITHGAM001 - Provide responsible gambling services

#### **Entry requirements or Pre-requisites**

There are no pre-requisites or entry requirements for this unit. Please note, undertaking this qualification prior to turning 18 years of age is permissible however individuals cannot work in a gaming environment until they have turned 18.

The RCG Competency Card is currently valid for a period of 5 years.

#### **Overview**

This course delivers the skills and knowledge required to provide a first aid response to a casualty. It applies to all people who may be required to provide a first aid response in a range of situations, including community and workplace settings.

Course covers unit of competency: HLTAID003 – Apply first aid.

#### Entry requirements or Pre-requisites

There are no entry requirements for this course, however students must be able to participate in practical role plays that require the student to sit, stand, crouch, and lift heavy/awkward objects.

## White Card

#### \$150.00 per person

**RTO ID 91434** 

#### **Overview**

This unit of competency specifies the mandatory work health and safety training required prior to undertaking construction work. The unit requires the person to demonstrate personal awareness and knowledge of health and safety legislative requirements in order to work safely and prevent injury or harm to self and others. It covers identifying and verbally reporting common construction hazards, understanding basic risk control measures, and identifying procedures for responding to potential incidents and emergencies. It also covers correctly selecting and fitting common Personal Protective Equipment (PPE) used for construction work.

#### **Entry requirements or Pre-requisites**

You must be at least 14 years of age and be able to present 100 Points of Identification to the trainer as listed on the SafeWork NSW website

https://www.safework.nsw.gov.au/licences-and-registrations/licences/evidence-of-identity, on the day of the course. These <u>must</u> be original documents. Document copies cannot be accepted.

Course covers unit of competency: CPCCWHS1001 Prepare to work safely in the construction industry.

## Forklift

#### \$650.00 per person

**RTO ID 91434** 

#### **Overview**

This unit specifies the skills and knowledge required to operate a forklift truck safely in accordance with all relevant legislative requirements. A person performing this work in NSW is required to hold a High Risk Work (HRW) licence issued by SafeWork NSW. This course includes both training in the required licencing unit of competency, and the required HRW Assessment under the SafeWork NSW National Assessment Instrument by an accredited assessor.

Joblink Plus Training and ATAC are approved by SafeWork NSW to conduct HRW assessments for forklift truck (class LF).

Course covers unit of competency: TLILIC0003 Licence to operate a forklift truck.

#### **Entry requirements or Pre-requisites**

No entry requirements or pre-requisites apply to the unit of competency, however in order to obtain a SafeWork NSW High Risk Work licence, students must:

- Be at least 18 years of age
- Be enrolled in and complete a recognised training course with a Registered Training Organisation (RTO) and have been assessed as competent by an Assessor working for the RTO
- Have literacy and numeracy skills at a level that enables the safe performance of high risk work
  Be able to present 100 Points of Identification to the assessor as listed on the SafeWork NSW website https://www.safework.nsw.gov.au/licences-and-registrations/licences/evidence-of-identity, on the day of the HRW Assessment. These *must* be original documents. Document copies cannot be accepted.
